Standardized Procedure for Processing New Member Applications.

- 1) All applications shall have a check attached for the full initiation fee, with separate check for the first month's dues.
- 2) Each application shall be posted for Active Member review and comment for not less than 30 days.
- 3) During the 30-day review and comment period the applicant shall be interviewed by the TYC Membership Committee.
- 4) After 30-day member comment period the application is submitted to the TYC Board of Directors for review, discussion, and vote.
- 5) Results of vote shall be communicated to applicant within 7 days of vote.
- 6) If application is rejected: The applicant shall be notified within 7 days of the vote and the undeposited check for the initiation fee shall be returned.
- 7) If application is approved:
 - a) The applicant shall be considered a Member of the TYC as detailed in the TYC Bylaws.
 - b) New member information is added to administrative database.
 - c) Credit card number is added to the database for all purchases , dues, and as security for delinquent charges.
 - d) An orientation shall be conducted by the TYC Membership Committee. As part of the orientation process the new member will receive a welcome package to include but not limited to:

Membership Cards

Copy of the TYC Bylaws

Copy of the TYC Code of Conduct

Copy of the most recent SpyGlass

Calendar of Events

Access to the "Members Only" website.
